The regular meeting of the Cobb County-Marietta Water Authority was held on February 20, 2023, at 2:30 p.m., in the Cobb County-Marietta Water Authority's Board Room. 5. Financial report

Ms. Rebecca Watkins, Senior Accountant, presented a summary of the January 31, 2023 Financial Statement (copy in file). Operating income for January was \$2,375,031, which exceeded expectations by \$234,538. Net income for January was \$3,430,789 which exceeded the budget expectation by \$1,144,365.

6. General Manager's report

Mr. Blackwell provided the following updates to the published General Manager's Report (copy in file):

- 1) 375 Lee Industrial Boulevard, Austell There was an Outlet Saddle Failure on February 19, 2023. Crews are on site working on repairs.
- 2) Wyckoff 6 MG Clearwell Addition

The project is now 381 days behind schedule according to IHC. (23 additional days) IHC has submitted 13 claim notices on the project, but to date has not attached dollar figures with the material claims. Types of claims include testing of rock anchors; pipe cost escalation; fasteners (bolts); leak testing; unsuitable soil; concrete supply; rock excavation; supply chain delays and pipe testing. In the contract, IHC is responsible for attendant overtime construction engineering costs as well as attendant construction engineering cost beyond the contractual project completion date. Staff has confirmed adequate retainage is being held to cover accrued engineering costs and liquidated damages liable to IHC as of January 31, 2023.

- 3) Blackjack Mountain 36-Inch Water Main Replacement Contractor, Garney continues to do project cleanup, grassing and paving. About 500 feet of 36-inch water main remains to be installed. Installation can begin when the bore under Sope Creek at Barnes Mill Road is completed by the boring subcontractor, BoreCo. Excavation and preparation of the bore launch pit is ongoing. Project completion is anticipated in May 2023.
- 4) Wyckoff, Raw Water Main Replacement Contractor, Garney has installed approximately 6,600 feet (93% of the project length) of the 54-inch water main. A conflict was discovered where the new 54-inch water main crosses the existing 60-inch water main near the final connection of the project. Staff is working with Garney to determine a solution, which will require a change directive. Staff is working with Garney to address issues related to residents accessing their homes and mail delivery service by constructing a temporary road.
- 5) Quarles Taste and Odor Process Improvements Project
 Delivery of the electrical MCC and power panel has been delayed by the supplier to March
 2023. The PAC Silo was delivered to the site on January 25th and installed on the 26th.
