

OLD HIGHWAY 41 & STILESBORO ROAD WATER MAIN REPLACEMENT PROJECT

PROJECT SCOPE:

The National Park Service (NPS) has initiated an effort to restore the historical condition of the Kennesaw Mountain National Battlefield Park. As a result, Cobb County Department of Transportation (CCDOT) has planned improvements along Old Hwy 41 that create conflicts with existing Cobb County-Marietta Water Authority (CCMWA) infrastructure. To resolve the conflicts, existing CCMWA water mains are being replaced, relocated, or abandoned to maintain service and reliability of the water system.

PROJECT LIMITS:

Alignment Section 1: Stilesboro Road Water Main

Installation of 7,200 linear feet of 12-inch water main to replace an existing 30-inch water main along Stilesboro Rd. Project begins at the intersection of Gilbert Road/Stilesboro Rd, runs northeast along Stilesboro Rd, and terminates at the intersection of Stilesboro Rd/Old Hwy 41.

Alignment Section 2: Marble Mill Road Water Main

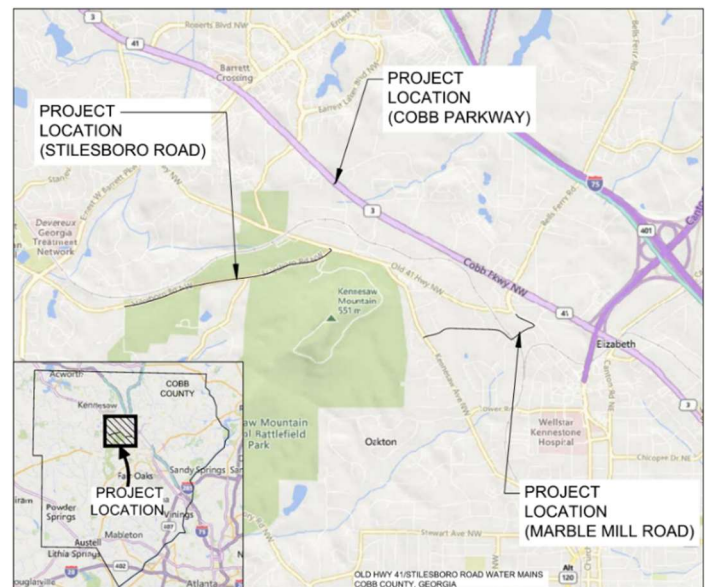
Installation of 4,800 linear feet of 16-inch water main. Project begins at the intersection of Church Street Ext/Old Hwy 41, runs southeast along Church Street Ext, turns southwest along Loudermilk Rd, turns west along Marble Mill Road, and terminates at the intersection of Marble Mill Rd/Kennesaw Ave.

Alignment Section 3: Cobb Parkway Water Main

Installation of 200 linear feet of 12-inch water main via trenchless crossing under Cobb Parkway. Project is located at the intersection of Cobb Parkway/White Circle.

Water Main Abandonments: Cobb Parkway, Old Hwy 41, and Kennesaw Avenue

Existing water mains to be taken out of service and remain in place. Minimal disturbance will be required at select locations along the water main to complete the abandonment.

Alignment #1: May 2025 - November 2025

Alignment #2: August 2025 - March 2026

Alignment #3: June 2025 - July 2025

Abandonments: May/Sept. 2025 - December 2025

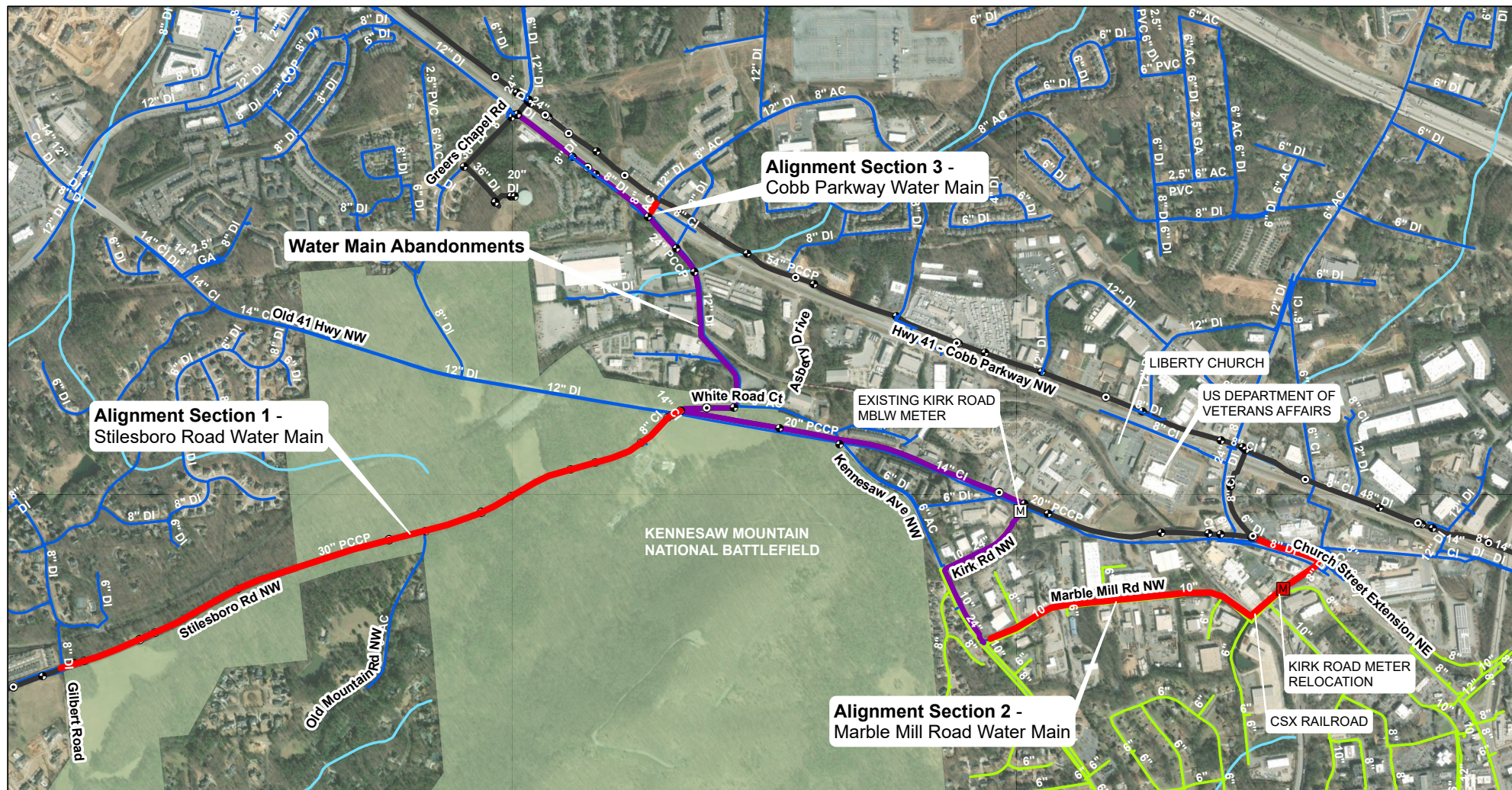
