Cobb County-Marietta Water Authority Minutes of Regular Meeting

September 21, 2020 - 2:30 p.m.

The regular meeting of the Cobb County-Marietta Water Authority was held on September 21, 2020, at 2:30 p.m., in the Cobb County-Marietta Water Authority's Board Room. Water Authority Board members present were: James Scott, Dan Buyers, Charlie Crowder, Mike Boyce, Grif Chalfant, and Corkey Welch. James Balli was excused from the meeting.

The meeting was called to order at 2:30 p.m. by Chair James Scott.

1. Invocation and Pledge of Allegiance

Mr. Brandon Smith offered the invocation and led the Pledge of Allegiance.

2. Approval of Minutes of Regular Meeting of August 17, 2020

Mr. Scott asked for approval of the minutes of the Regular Meeting of August 17, 2020. Mr. Boyce made a motion to approve the minutes as presented. Mr. Chalfant seconded the motion; motion passed 6/0.

3. Financial report

Ms. Allison Clements, Director of Finance, presented a summary of the August 31, 2020 Financial Statement (copy in file). Operating income for August was \$4,962,102, which exceeded expectations by \$834,614. Net income for August was \$4,959,509, which exceeded expectations by \$718,049.

Ms. Clements reported a meeting was held with Raymond James to discuss a recommendation to refinance the 2015 Series Bonds. Staff does not recommend further consideration at this time.

4. Pension Committee reports

Chair Stanley Brinkley gave the reports from the August 17 and August 19 meetings of the Pension Committee (copies in file).

5. Restatement of Retirement Plan

Mr. Buyers made a motion to approve the proposed Second Amendment to the Cobb County-Marietta Water Authority Retirement Plan (copy in file) to define "Delayed Retirement Death Benefit" and offer limited lump sum options to Participants and Beneficiaries. Mr. Chalfant seconded the motion; motion passed 5/1 with Mr. Boyce voting against, citing his opposition to Section 3 of Amendment (Partial Lump Sum).

6. Bid Results – Macland Road 24-Inch Relocation and Corner Road/ Florence Road Modifications

Mr. Page referred to the memorandum in the board package (copy in file). Mr. Boyce made a motion to award the construction contract for the Macland Road 24-Inch Pipeline Relocation and Corner Road/Florence Road Modifications Project to Ruby-Collins, Inc. of Smyrna, Georgia for the verified low bid of \$1,316,585. Mr. Welch seconded the motion; motion passed 6/0.

7. Task Authorization – Wyckoff Clearwell No. 3 Supplemental Engineering Services

Mr. Page referred to the memorandum in the board package (copy in file). Mr. Welch made a motion to approve the execution of a new Task Authorization valued at \$257,814 through the Demand Services Engineering Contract with Engineering Strategies, Inc. of Marietta for Supplemental Engineering Services for the Wyckoff Clearwell No. 3 Project. Mr. Crowder seconded the motion; motion passed 6/0.

8. Engineering Contract Modification - Quarles Water Treatment Plant 2 SCADA Replacement

Mr. Page referred to the memorandum in the board package (copy in file). Mr. Boyce made a motion to approve a Contract Modification valued at \$424,264 to the Engineering Services Contract with Hazen and Sawyer, PC for the James E. Quarles Plant 2 SCADA Replacement Project. Mr. Chalfant seconded the motion; motion passed 6/0.

9. Professional Services Contract - Ductile Iron Pipe Condition Assessment

Mr. Cole Blackwell, Director of Operations, referred to the memorandum in the board package (copy in file). Mr. Boyce made a motion to approve a contract with Pure Technologies U.S., Inc. to provide professional services for condition assessment of the Maner Road Water Main for the proposed estimated fee of \$219,712.50, and sole-source approval for Pure Technologies U.S., Inc. to provide any other non-destructive pipe evaluation and condition assessment services with approved budgets through December 31, 2021. Mr. Chalfant seconded the motion; motion passed 6/0.

10. Purchase of Portable Generator for Pumping Stations

Mr. Blackwell referred to the memorandum in the board package (copy in file). Mr. Welch made a motion to approve the purchase of a portable Doosan G400 Generator and accessories through Gen-Tech Inc. of Gainesville, Georgia for the General Services Administration Contract (GS-07F-0494V) price of \$149,829.92. Mr. Chalfant seconded the motion; motion passed 6/0.

11. Pipeline Contractor Prequalification – Reeves Young, LLC

Item was tabled at the August meeting. Staff withdrew recommendation.
